Definitions for KPIs

- Scope 1 CO2e emissions include direct greenhouse gas emissions that occur from sources that are controlled or owned by Ahlstrom. (Note: An error was discovered in the reporting for the year 2023. Scope 1 carbon dioxide equivalent emissions were 970 thousand tons, and not 916 thousand tons as reported on Sustainability Report 2023 Page 26.)
- Scope 2 CO2e emissions include greenhouse gas emissions from the generation of purchased electricity, steam, heating and cooling consumed by Ahlstrom. Scope 2 emissions are reported as market based data.
- Scope 3 emissions include indirect greenhouse gas emissions that occur in Ahlstrom's upstream and downstream value chain. Upstream emissions include categories 1: Purchased goods and services, 2: Capital goods, 3: Fuel and energy-related activities, 4: Upstream transportation and distribution, 5: Waste generated in operations, 6: Business travel, 7: Employee commuting, and 8: Upstream leased assets. Downstream emissions include categories 9: Downstream transportation and distribution, 10: Processing of sold products, 11: Use of sold products, 12: End-of-life treatment of sold products, 13: Downstream leased assets, 14: Franchises, and 15: Investments. The limited assurance covers categories 1, 3, 4, 9, and 12, which constituted 79,8 % of total Scope 3 emissions in 2023.
- Total weight of air pollutants includes selected emissions to air, relevant to Ahlstrom operations, that occur from sources that are owned or controlled by Ahlstrom. Emissions are included only from sites that have a legal, regulatory or other requirement to monitor and report on these emissions. For pollutants included in Annex II of Regulation (EC) No 166/2006, emissions are reported only from facilities that exceed the applicable threshold value. Two sites that will be closed during 2024 are excluded from the data.
- Total energy consumption consists of energy from all sources, including energy purchased from external sources and energy produced by the organisation itself (self-generated). Energy sold outside of the



company is deducted from total self-generated and purchased energy, resulting the amount consumed by Ahlstrom.

- Total renewable energy consumption refers to energy from solar, wind, hydro or biofuels. For years 2021 and 2022 the data covers only self-generated energy. For 2023 also purchased energy from renewable sources is included.
- Total self generated renewable energy is the amount produced by the organization itself.
- Water intake intensity refers to the ratio of total water withdrawal from all types of sources divided by net tons of paper and pulp production.
- Water intake refers to total water withdrawal from all types of sources.
- Water consumption measures water used by Ahlstrom such that it is no longer available for use by the ecosystem or local community in the reporting period. The reported data includes some adjustments due to incomplete or unavailable information from certain plants.
- Total non-hazardous waste refers to waste not containing, or not contaminated with, hazardous substances generated during our activities. Data is reported in wet state.
- Total weight of hazardous waste refers to waste that are classified as hazardous according to the local regulations generated during our activities. Data is reported in wet state.
- Waste utilized refers to hazardous and non-hazardous waste that is diverted from disposal by finding useful purposes for the waste products, including reuse, recycling or recovery. Data is reported in wet state.
- Waste to landfill includes the amount of non-hazardous and hazardous waste generated in the operation and disposed of in landfills. Data is reported in wet state.
- Employee Safety Participation represents the share of all employees who actively participated in minimum one additional health and safety preventative activity, monitored monthly, with annual weighted average.
- Total Recordable Incident Rate is the sum of all recorded occupational accidents for own employees, including lost time accidents, occupational diseases, light duty cases, and other recordable incidents, divided by total hours worked x 200,000.
- Number of days lost to work-related injuries, fatalities and ill health refers to the total number of days lost for own workforce as well as temporary workers.
- Employee Net Promoter Score indicate how likely Ahlstrom employees are to recommend Ahlstrom as a workplace. The manufacturing industry is used as the reference group.
- For all the below social targets, the reporting scope is all manufacturing locations and 5 business hubs.
- Share of employees offered healthcare refers to percent of employees being offered healthcare benefits at the same level or above the minimum statutory requirements. Shares separately for white and blue collar workers.
- Share of employees covered with healthcare refers to employees that are using the healthcare package offered by Ahlstrom. Shares separately for white and blue collar workers.
- Ratio of the annual total compensation for the highest paid individual, to the median annual total compensation for all employees.



- Share of employees covered by collective agreements refers to all regular employees that are under a collective bargaining agreement, including employees who are not union members but may nevertheless be subject to collective bargaining agreements.
- Number of facilities covered by collective agreements refers to the count of facilities where collective agreements are present. Topics coverd by Collective Bargaining Agreements will vary, but common subjects included in facility CBA's include administration of working hours, joint health and safety efforts, and working conditions.

- Gender balance top leaders measures the share of women among top leaders as defined based on position.
- Gender balance total workforce measures the share of women of total workforce.

- Gender balance top leaders measures the share of women among top leaders as defined based on position.
- Gender balance total workforce measures the share of women of total workforce.
- Total Recordable Incident Rate is the sum of all recorded occupational accidents for own employees, including lost time accidents, occupational diseases, light duty cases, and other recordable incidents, divided by total hours worked x 200,000.
- Employee Safety Participation represents the share of all employees who actively participated in minimum one additional health and safety preventative activity, monitored monthly, with annual weighted average.



- Share of employees offered healthcare refers to percent of employees being offered healthcare benefits at the same level or above the minimum statutory requirements. Shares separately for white and blue collar workers.
- Reported child and forced labor cases via our Speak Up channel.

Scope 1 carbon dioxide equivalent emissions were 970 thousand tons, and not 916 thousand tons as reported on Sustainability Report 2023 Page 26.)
- Water intake intensity refers to the ratio of total water withdrawal from all types of sources divided by net tons of paper and pulp production.
- Sustainability and biodiversity course completion refers to share of employees that have completed the Sustainability training course, that focuses especially on biodiversity as a new topic. The course will be launched in 2025, and includes introduction to sustainability and it's meaning at Ahlstrom as well as topics such as biodiversity, circular economy and climate change.
- Waste to landfill includes the amount of non-hazardous and hazardous waste generated in the operation and disposed of in landfills. Data is reported in wet state.
- Non-durable products to be technically reusable, recyclable or compostable refers to share of webgrades that are one time use products or used over a short period of time, e.g., hours and that have a positive end-of-life option.
- The certified share of total volume of natural fibers.
- Supplier Code of Conduct compliance refers to the share of suppliers that are signatories or considered compliant of suppliers with spend of above one million euro annually.
- Supplier ESG engagement program participation refers to the share of suppliers, based on total spend, who are part of our program, where we evaluate our suppliers' ESG management processes in environmental, social and governance topics through the EcoVadis supplier program. The program started with the most CO2-intense product suppliers.
- Code of Conduct course completion refers the share of office employees that have completed at least biennially the Code of Conduct course. Course includes topics such as anti-bribe, fair competition, compliance, conflict of interest, data privacy, company assets and information.
- Information security course completion refers to the share of office workers that have completed annually the information security awareness training course. Course has been offered from 2021 but annual historical data unavailable.



- Office workers trained on corruption, fraud and money laundering refers to our efforts to expand ethics training to all office employees for further topics through e-learning.
- Locations reported for social KPIs are all manufacturing locations and 5 business hubs.

Independent Practitioners' Limited Assurance Report

Report on Ahlstrom's Selected Sustainability Information

We conducted our engagement in accordance with International Standard on Assurance Engagements (ISAE) 3000 (Revised), Assurance Engagements Other Than Audits or Reviews of Historical Financial Information issued by the International Auditing and Assurance Standards Board (IAASB). Our responsibilities under this standard are further described in the "Our responsibilities" section of our report.

We are independent from the company according to the ethical requirements in Finland and we have complied with other ethical requirements, which apply to the engagement conducted.

Our firm applies International Standard on Quality Management (ISQM) 1, Quality Management for Firms that Perform Audits or Reviews of Financial Statements, or Other Assurance or Related Services Engagements, issued by the IAASB. This standard requires the firm to design, implement and operate a system of quality management, including policies or procedures regarding compliance with ethical requirements, professional standards, and applicable legal and regulatory requirements.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our conclusion.

Responsibilities for the Selected Sustainability Information

The Management of Ahlstrom is responsible for:

 designing, implementing and maintaining internal control relevant to the preparation of the Selected Sustainability Information such that they are free from material misstatement, whether due to fraud or error;



- selecting or developing suitable criteria for preparing the Selected Sustainability Information and appropriately referring to or describing the criteria used; and
- preparing the Selected Sustainability Information in accordance with the reporting criteria, i.e.
 Ahlstrom's own reporting principles (definition of KPI's) and the information and assertions contained within it.

Inherent limitations

Inherent limitations exist in all assurance engagements due to the selective testing of the information being examined. Therefore fraud, error or non-compliance may occur and not be detected. Additionally, non-financial data may be subject to more inherent limitations than financial data, given both its nature and the methods used for determining, calculating and estimating such data.

Our responsibilities

We are responsible for:

- planning and performing the engagement to obtain limited assurance about whether the Selected Sustainability Information is free from material misstatement, whether due to fraud or error;
- forming an independent conclusion, based on the procedures we have performed and the evidence we have obtained; and
- reporting our conclusion to the Management of Ahlstrom.

Summary of the work we performed as the basis for our conclusion

We exercised professional judgement and maintained professional skepticism throughout the engagement. We designed and performed our procedures to obtain evidence about the Selected Sustainability Information that is sufficient and appropriate to provide a basis for our conclusion. Our procedures selected depended on our understanding of the Selected Sustainability Information and other engagement circumstances, and our consideration of areas where material misstatements are likely to arise. In carrying out our engagement, the procedures we performed primarily consisted of:

- Interviewing the members of relevant staff responsible for providing the Selected Sustainability Information;
- Assessing the application of Ahlstrom's reporting principles (definition of KPI's) in the presentation of the Selected Sustainability Information;
- Assessing the data management processes, information systems and working methods used to gather and consolidate the Selected Sustainability Information;
- Reviewing the presented Selected Sustainability Information and assessed its quality and reporting boundary definitions;
- Assessing the Selected Sustainability Information data accuracy and completeness through a review of the original documents and systems on a sample basis.



The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.
